RESPONDENT HOMEADVISOR, INC.'S UNOPPOSED MOTION TO RESCHEDULE ORAL ARGUMENT AND DEADLINE FOR SUBMISSION OF MATERIALS

Respondent HomeAdvisor, Inc., respectfully submits this unopposed motion to adjust (i) the July 14, 2022 date set by the Commission for oral argument on Complaint Counsel's Motion for Summary Decision and (ii) the July 11, 2022 date set by the Commission for submission of materials to facilitate presentations during oral argument. Respondents do not seek any change to the September 12, 2022 deadline set by the Commission for rendering a decision on Complaint Counsel's Summary Decision Motion. Complaint Counsel have apprised Respondent that they do not oppose this motion, provided that the Commission is available for another date in July 2022 and that it does not impact the September 12, 2022 deadline set by the Commission.

On June 29, 2022, the Commission entered an Order Scheduling Oral Argument and Extending Deadline for Commission Ruling. This Order set oral argument for July 14, 2022 at

11 am and set July 11, 2022 at 5 pm as the deadline for the parties to submit to the Secretary of the Commission, and provide to opposing counsel, any short written or electronic compilation of material to facilitate its presentation during the oral argument.

Respondent's two lead counsel on the Summary Decision Motion are unavailable on July 11, 2022 and July 14, 2022. One has long-standing plans to be out of the country from July 3 - 14, and the other is scheduled to be traveling from July 9 - 17. In addition, Respondent's inhouse counsel with day-to-day responsibility on this matter will be traveling from July 6 – 17. Respondent respectfully submits that it would be prejudiced if its two lead counsel on the Summary Decision Motion would be unable to participate in the important argument that the Commission has scheduled and the preparation of material to facilitate the argument.

Respondent therefore respectfully requests that (i) the oral argument on Complaint Counsel's Motion for Summary Decision be adjourned by one week to July 21, 2022, or for a date in July as soon thereafter as would be convenient for the Commission, and (ii) the deadline for submitting any materials to facilitate the argument be adjourned until three days before the new argument date.¹
